## About the Earned Income Tax Credit (EITC)

The EITC is a tax benefit for people who worked full or part-time in 2008. Check the chart below to see how much you could qualify for.

You may be eligible for the Earned Income Tax Credit if:

You are:	and you earn LESS than:	then you may qualify for a credit or refund up to:
A married couple w/ 2 or more qualifying children	\$41,646	\$4,824
A single person w/ 2 or more qualifying children	\$38,646	\$4,824
A married couple w/ 1 qualifying child	\$36,995	\$2,917
A single person w/ 1 qualifying child	\$33,995	\$2,917
A married couple w/ no qualifying children	\$15,880	\$438
A single person w/ no qualifying children	\$12,880	\$438

Note: Investment income must be \$2,950 or less for the year.

Other credits which you may qualify for: Child Tax Credit, Additional Child Tax Credit, Child and Dependent Care Credit, and the Economic Stimulus Payment if you did not receive one in 2008.
